#### Meeting November 22, 2010

The meeting of Mount Pleasant Borough Council was called to order by President Bauer at 7:03pm in Council Chambers at 1 Etze Avenue, Mount Pleasant, PA 15666. The Pledge of Allegiance was said and there was a moment of silence for our deployed troops. President Bauer directed Borough Manager Landy to take roll. Councilmen Beranek, McCloy, Pritts, Tate and Councilwomen Stevenson and Ruszkowski were present. Mayor Lucia was present and the Solicitor was absent. President Bauer stated we have a quorum.

#### **Reading of the Minutes:**

A motion was made by Councilman Beranek to dispense with the reading of the minutes of November 1, 2010. Motion seconded by Councilwoman Ruszkowski. Motion carried 7-0.

Public Comment: None

#### **Speakers:**

Nino Barsotti and LuAnn Hout of the Mount Pleasant BDA presented Council with a copy of the 2011 BDA Budget. The tax rate will remain the same and the BDA Board feels they can maintain the In-Town Shops using the same numbers.

Mr. Landy asked Mr. Barsotti if he has a copy of the Sign Grant Program. Mr. Barsotti said he has a proposed copy and will take it to their attorney for review and then to Council for their review. Mr. Barsotti said the BDA has allotted \$5,000 for the program and will offer \$500 matching grants. Ms. Hout said there is verbiage in the grant that states they must comply with the Sign Ordinance. A discussion ensued regarding items on the budget.

Albert J Saussol and Mike Chambers, Utility Service Partners, Inc. spoke to Council regarding their services. Utility Service Partners, Inc. offers service line warranties. Their most popular are sewer line warranties and water line warranties. This warranty covers the costs that homeowners are liable for if something happens. Utility Service Partners, Inc. would put together a letter and send it to the residents offering their warranty program. Council would approve the letter before it is mailed. They would not do any telemarketing. After a homeowners signs up for the service, when they have problems they would call Utility Service Partners, file a claim and the company would send a contractor to fix it. Only local contractors will be used. The warranty would cover what homeowners insurance does not. After the claim has been processed the resident will receive a satisfaction survey. At the end of the year Utility Service Partners, Inc. will give 10% of their annual revenues from contracts in the Borough to the Borough. President Bauer asked if the 10% could be given back to the customers as a rebate instead of to the Borough.

#### Mayor's Report:

Mayor Lucia said that Troops returned home on November 12, 2010 and the Borough gave them an escort to the Armory and a lot of people came out to pay tribute to the soldiers.

Mayor Lucia said that the Veterans Day Tribute was a great success this year. Once again people came out to pay their respects to our Veterans. Mayor Lucia said people seem to be excited about the new Veterans Park Video Screen. Councilman Tate said that Councilman Tabita is working on getting a demo of the screen so people can see it.

President Bauer said he attended the Library Board meeting for the first time as a board member. President Bauer said he was given the information he requested including their 2009 audit and he feels they have a good plan for improvements to the library next year. The library is having some financial difficulties right now and plan on soliciting some of the local businesses and clubs during its annual campaign.

## **Borough Manager's Report:**

Borough Manager Landy made the following report:

- The report of the calculation of estimated real estate collections shows a downward trend.
- The 2011 budget is complete and all numbers that can be verified have been.
- The Christmas Programs for December 4<sup>th</sup> are complete. The day is broken into two phases. In the morning will be the parade, Santa, hot chocolate and the hot dogs and marshmallows at the Log Cabin. The parade this year will be "An Old Fashioned Christmas" and will be sponsored by Medic 10. In the evening will be

- Ordinance #582 lists streets where parking is prohibited. Any changes Council wishes to make should be made all at once.
- MRM Trustnotes outlines how to handle workers comp claims and we should follow their guidelines.
- The Jack Czeka Foundation is an organization that is interested in doing projects in the Borough. One of their ideas would be to put planters on Main Street and they would maintain the planters.
- The Council Christmas Party will be after the meeting on December 6, 2010 and will be at the Village Restaurant. Allied Waste, Tucker Arensberg, Standard Bank and the Mount Pleasant Glass and Ethnic Festival are sponsoring the party.
- The Christmas party for borough employees will be held on December 23, 2010 from 11am to 2pm and all of Council is invited.
- The Premoshis Christmas displays will be put up tomorrow by the Street Department.
- Mr. Landy and Mayor Lucia will be hosting a weekly radio show on WKVE 103.1FM. Guests would include members of Council, Township officials and School officials.

### **New Business:**

Councilwoman Stevenson thanked Mayor Lucia and members of the Mount Pleasant VFD for their help moving picnic tables at the Log Cabin on Community Light Up night.

Councilwoman Stevenson addressed Council about the funds for the Cat Committee being reduced. Councilwoman Stevenson said she appreciates the support of Council and the financial support for the first two years of the program. She also feels that the Cat Committee deserves respect and recognition for taking on a problem that the Borough received complaints about and dealt with for many years. The Cat Committee is dealing with the problem as professionally as they can. The committee owns approximately \$1,000 worth of professional equipment and are constantly studying and learning of better ways to move forward. The committee spent \$8,000 the first year and this year will spend in excess of \$10,000. The money is raised through fund raising efforts and the number of volunteers has more than doubled and the amount of hours put in continues to grow. President Bauer said he respects the committee but was under the assumption that the first two years the Borough would provide some start up money but after that it would not be a line item in the budget. Councilwoman Stevenson said that the committee does occasionally go outside of the Borough, but in those cases the people are asked to pay for the service. No Borough money is being spent outside of the Borough.

Councilman McCloy brought up the subject of a community yard sale. He has people willing to volunteer to help and he can get a committee of interested people together if Council wants to go forward with the idea. Mr. Landy suggested asking other communities how they handle their community yard sales because there is work involved in a project like this.
