Meeting November 23, 2009

The meeting of Mount Pleasant Borough Council was called to order by Vice President Bauer at 7:05pm in Council Chambers at 1 Etze Avenue, Mount Pleasant, PA 15666. The Pledge of Allegiance was said and there was a moment of silence for our deployed troops. Vice President Bauer directed Borough Manager Landy to take roll. Councilmen Beranek, Crivella, Tate and Councilwomen Ruszkowski and Stevenson were present. Mayor Lucia and Solicitor Toohey were present. Vice President Bauer stated we have a quorum.

Reading of Previous Minutes:

A motion was made by Councilwoman Stevenson to dispense with the reading of the minutes of November 2, 2009. Motion seconded by Councilwoman Ruszkowski. Motion carried 6-0.

Public Comment: None

Speakers:

Mr. Tim Bates, Business Analyst, Small Business Development Center, Saint Vincent College, Latrobe PA spoke to Council about the program and services provided. The Small Business Development Center offers business counseling to small start-up businesses. The Saint Vincent branch covers Westmoreland and Fayette Counties. Some of the issues they offer counseling on are various licenses, sales tax and business plan development. The business plan is very important because it is what you would take to lenders for financing. Financial Analysis is also provided from the aspect of the buyer who is interested in purchasing an existing business. The Small Business Development Center also provides references to different sources of capital. They also provide assistance with marketing and sales strategies and tactics. Mr. Bates discussed different classes open to the public and went on to outline other services provided. Mayor Lucia asked Mr. Bates if he ever steers new businesses to a certain area. Mr. Bates said that it all depends on the business, but Mount Pleasant's plus is it's busy Main Street.

Mr. Don Good, Medic 10 Chief spoke to Council regarding a change in the format for their paid staff. Since the fire in the ambulance bay they have started working people as needed for twenty-four hour coverage. Personnel will be provided by a staffing agency and will all be certified Emergency Medical Technicians. All costs of the program will be the responsibility of Medic 10. Workers Comp and Unemployment Compensation are the responsibility of the staffing agency. No cost will be incurred by the Borough of Mount Pleasant for this program. This additional staffing is being done to ensure immediate response for emergency calls. Councilwoman Ruszkowski asked for the ratio of paid staff and volunteers. Mr. Good said right now it is 1/3 paid and 2/3 volunteer. Mr. Landy said that he feels Mr. Good is asking for a change in the existing ordinance to include language allowing them to use paid staff whenever they are needed.

A motion was made by Councilwoman Stevenson to turn the request by Medic 10 over to the Public Safety Committee. Motion seconded by Councilman Crivella. Motion carried 6-0.

Mayor's Report:

Mayor Lucia said that problems are reoccurring at Frick Park with bicycles. Walkers are unable to use the walking track because of the bike riders. He has given a directive to the Police Department that he wants the area cleared for walkers. There was vandalism at the playground. It will have to be made clear that it is not a place for juveniles to congregate.

Mayor Lucia suggested that the entrances to the park should be designated as orange areas where no one should be standing or loitering. He also suggested that bike racks be put in the park so that bikes are not lying on the walking track. Council again discussed removing the fountain area at Frick Park. Councilman Tate said that the cameras the Borough purchased have to be mounted on the new concession stand at Frick Park. Councilman Crivella said that a sign with park rules needs to be erected. Borough Manager Landy said that the Parks Ordinance states that there can be no malicious loitering. Our Police Department needs to enforce the ordinance. Mr. Landy suggested a meeting between the Police Department and Solicitor Toohey so that they understand the ordinance.

Mayor Lucia said that the dumpster by the basketball courts is collecting a lot of trash because it is being used by people who are not authorized. The dumpster is supposed to be for the Central VFD, the

Library and the Municipal Building. Vice President Bauer said we should lock the dumpster and give authorized people a key.

Installing the surveillance cameras was discussed. Borough Manager Landy said that when we received grant money for the cameras it only covered the cameras which need to be located at the Doughboy area. Armstrong Cable said at the time that they would install the cameras for free as a donation to the Borough. But the cameras have to be directed to a location where the footage can be recorded. Council directed Mr. Landy to send a letter to Armstrong Cable asking them to install the cameras as soon as possible.

Solicitor's Report:

Solicitor Toohey said that the reason the ordinance re-codification could not be adopted at tonight's meeting is because it requires 30 days to notify the County of any Zoning or Subdivision changes in the Zoning Ordinance. Mr. Toohey said that Council can agree tonight to advertise the re-codification ordinance so that it can be adopted at the January 4, 2010 meeting. Council said that there are changes to be made before we advertise.

The Pennsylvania Environmental Council does visioning and will make recommendations for used of property in the Borough. How the property could be renovated and where money may be available. The banks along Shupes Run from Main Street to Cook's Lumber was discussed. They may be able to help with cleaning up the area.
- The 2009 Annual Christmas Parade will be held on December 5, 2009 at 11:00am. There are other activities scheduled throughout the day. There will be a Candle Light Procession this year at 6:30pm from the Central Fire Station to the Gazebo. At the Gazebo there will be a narration of various Christmas stories..
