Borough Manager Landy said that Liquid Fuels money should be deposited sometime in the next couple of weeks and we can look at paving.

A motion was made by Councilman Tate to approve the Treasurers Report as read. Motion seconded by Councilman Pritts. Motion carried 9-0.

President's Report:

President Bauer said that an Executive Session was held at 6:00pm before this regular meeting to discuss personnel.

President Bauer said he attended the G5 Conference and he feels it was even more of a success this year than last. He feels there was a lot more interaction this year. President Bauer said he would like to see the meeting of council members last longer next year because there was still more to be discussed.

President Bauer reported that the Borough was awarded four more DCED Grants. \$10,000 for surveillance cameras, \$10,000 for a wood-chipper, \$5,000 for an early warning siren and \$5,000 for wiring for holiday decorations.

Borough Manager's Report:

Borough Manager Landy said he appreciates Counciløs support of the G5 Conference. Ligonier, Greensburg and New Stanton have already expressed interest in being a part of next yearøs conference. Mr. Landy said that this year there was discussion of forming a consortium for purchasing. That may be something to look into in the future.

Mr. Landy said he received a request from Mount Pleasant Windows on Main Street to be able to put cones out to save parking spaces for their delivery trucks. It would be on Thursdays from 8am to 9am and 0n Fridays from 8am to 9am and 1pm to 2pm. There are no meters on that section of Main Street. Council agreed to give Mount Pleasant Windows permission to do put cones out during the requested times.

Mr. Landy said that at an earlier meeting Ed Howley from B.I.U. offered Council options on how to handle rental inspections. He would like an answer from Council on which options we want to go with.

Mount Pleasant Rotary will be holding the 2011 Citizen of the Year Banquet at McCali Manor on April 3rd. This year & Citizen of the Year will be Nino Barsotti. Tickets to the banquet are \$30 each. Council agreed to pay for council member & tickets.

Mr. Landy said that there have been some property reassessments in the Borough resulting in lower tax income. This has been happening for the last three years and income for the Borough is dropping. Tax Collector Carol Yancosky said taxes are going to continue to drop and she doesnot see a possibility for increase since there is no room for expansion.

Mr. Landy asked Council to approve a memo he would like to give to the supervisors of WWT, the Street Department and Police Department regarding keeping costs down in 2011 including gasoline.

Mr. Landy gave Council a copy of the newspaper article that posted populations from the 2010 Census. The population of Mount Pleasant Borough has decreased.

Waste Water Treatment Report: None

Streets Report:

Council discussed the work being done at Jack Bobbøs Park. Councilman Tate said that he feels it would be less expensive to use cement on the walkway and other areas instead of asphalt.

Council discussed requesting bids for a 2011 paving project and the money available to do the project. Borough Manager Landy said that the Borough has a CDBG grant for \$41,000 and the rest of the cost would have to come from Liquid Fuels. Councilman Tate said that alleys would not have to be included in the bid request because the Street Department can tar and chip the alleys.

Zoning and Ordinance Report:

Councilman McCloy said he received correspondence from B.I.U. laying out proposal options for Rental Property Inspection Fees.

- Option 1: 100% of fees collected go to BIU. All fees are collected by BIU. All letters and correspondence generated by BIU Regional Office. Monthly reports sent to Mount Pleasant Borough.
- Option 2: 90% of fees collected go to BIU. All fees are collected by Mount Pleasant Borough. BIU will bill Borough once a month. All letters and correspondence generated at the BIU Regional Office. Monthly reports sent to Borough.
- Option 3: 80% of fees collected go to BIU. All fees are collected by Borough. BIU will bill Borough once a month. All letters generated by Borough, all correspondence there after handled by BIU Regional Office. Monthly reports sent to Borough.

Council discussed a date for the Mount Pleasant Community Yard Sale. Councilman McCloy proposed June 11, 2011.

President Bauer said Council has to determine who is going to enforce borough ordinances, including the Sign Ordinance. President Bauer said he would like a decision by the next council meeting.

Borough Manager Landy said we have received two sign applications that will be involved in the BDA Sign Grant program.

Community and Economic Development/Grants Report:

Councilman Tabita said he does not believe there will be any state funding for The Frick Communities. The Borough will have to change its focus and decide how to fund the project without state funds.

Councilman Tabita said that in the past the Borough had park supervisors and he feels it would be beneficial to re-institute that program for the summer of 2011.

Veterans Park Report:

Councilman Tate said he would like the Borough to fund the Video Wall at Veterans Park. He feels that people will respond better if they can see the video wall in place. Councilman Tabita said that the Borough has \$15,000 budgeted for Park Improvements and he has possible donations totaling approximately \$10,000.

Parks and Recreation Report:

Councilman Crivella said he provided Council with a list of citizens who would like to be on the Proposed Parks and Recreation Advisory Committee. If Council approves, these people could be appointed at the next meeting.

Councilman Crivella said he will contact the local colleges to see if they would have any interns available that we could use for a parks program this summer.

Councilman Crivella said he would like the Parks and Recreation Committee to have a meeting to walk through the parks to see how they fared over the winter.

Borough Manager Landy said that the State Liquor Store in Mount Pleasant needs to inform their state office that the Borough of Mount Pleasant has a contract with Allied Waste for all garbage pickup in the Borough.
